- Topic:** **“Birding America’s First Canal”**

Discover the birds of Old Santee Canal Park, a historic swamp landscape that once served as America’s first canal. This presentation highlights common and notable bird species found at the park. Learn the historical significance of the park, as well as the feathered friends that call it home today. From wading birds to songbirds, Old Santee Canal Park provides critical habitat and scientific research for both resident and migratory species. By combining history and birding, this program shows how a centuries-old engineering project became a haven for birds.

Brad Sale is the Park Director of Old Santee Canal Park and has served in that role since 2007. He holds a bachelor’s degree in Marine Science and Biology from Coastal Carolina University and a master’s degree in Educating for Sustainability from Antioch University New England. A world traveler, naturalist, and photographer, he often blends all three to connect people with place.

Brad’s career has taken him to Georgia, Hawaii, Tennessee, and Vermont. He oversees daily operations of the 300-acre Old Santee Canal Park, owned by Santee Cooper, home to America’s first canal, the 180-year-old Stony Landing Plantation House, the site of the construction of the *Little David*, and Fort Fair Lawn, one of only two remaining Revolutionary War forts in South Carolina.
